The notice was issued to the Principal of the Institution seeking explanation as to why the proceedings be not initiated u/s. 20 of the said Act of 2015.

After notice, the Officials of the institution appeared before the Authority on 25/08/2022 and admitted the default in submitting the proposal and requested to take a lenient view and permit them to submit the proposal for the academic year 2019-2020 & the institute shall not opt for no upward revision of fees for the academic year 2020-2021 and apply the fees as approved for the academic year 2019-2020 for the next academic year 2020-2021.

In view of contravention of section 14(1)(a) of the said act 2015 committed on the part of the Management running the Institute it was decided to impose the penalty of Rs. 1 Lakh subject to payment of penalty & allow the Institute to submit the proposal for approval of fees for the academic year 2019-2020.

The Institute has paid the penalty and submitted the proposal for approval of fees for the academic year 2019-2020 & no upward revision of fees for the academic year 2020-2021.
